Krasser, Dickey and Hoover voted aye. Emergency Management/Safety Director Mike Thronton informed the Board that he will be attending a mass notification training this week and discussed severe weather chances for the County. Sheriff Bill Ingram informed the Board that he will not seek reelection. Monthly reports submitted by Assessor, County Clerk, Health Department and Sheriff were approved by general consent. Motion by Dickey to bring from table and approve Inter-Governmental Agreement between Comanche Nation, Frederick Public Schools, City of Frederick and Tillman County District #2 for reconstruction of parking lots and roads. Krasser, Dickey and Hoover voted aye. Motion by Dickey to bring from table and go out for bids for Frederick Public School Parking Lots & Streets Project, Bid #3-2024. Krasser, Dickey and Hoover voted aye. Motion by Dickey to table action to approve Interlocal Cooperative Agreement between Tillman County and Comanche County, FY2024. Krasser, Dickey and Hoover voted aye. Motion by Dickey to approve Transfer of Appropriations in the amount of \$2,400.00 from Capital Outlay to Juvenile Detention Fees, General Fund. 


