

April 27, 2020, 9:00 A.M., the Board of Tillman County Commissioners met in a regularly scheduled meeting with Chairman Joe Don Dickey presiding. Members present were Kent Smith and Greg Petty. Minutes of the previous meeting were read by County Clerk Cacy Caldwell. Motion by Smith to approve the minutes as read. Dickey, Smith and Petty voted aye. Emergency Management/Safety Director Randy Hasley informed the board that a third shipment of PPE supplies has been received and given to the jail and to local volunteer fire departments. Discussion was held regarding projected decrease in funding for roads and bridges. Transfers of Appropriations as follows: \$2,000.00 from General Personnel Services and \$575.00 from General Capital Outlay to Juvenile Detention Fees, General Fund; \$8,000.00 from M&O to Capital Outlay, Health Fund; and, \$1,500.00 from Assessor M&O to Assessor Capital Outlay, and \$3,619.85 from Visual Inspection Travel and \$2,749.13 from Visual Inspection M&O to Visual Inspection Capital Outlay, General Fund. Dickey, Smith, and Petty voted aye. Purchase orders and payroll were approved by general consent and the following warrants were issued:




