Motion by Krasser to amend Resolution #1899 for County Road Machinery and Equipment Revolving Fund participation, FY2027, updated request for District 2. Dickey, Krasser and Hoover voted aye. 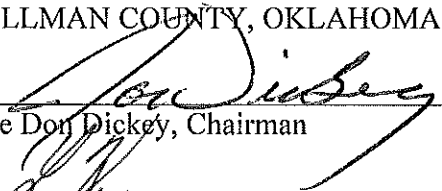

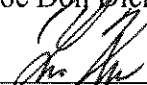
