Motion by Krasser to approve the minutes as corrected to include omitted vote. Dickey, Krasser, and Hoover voted aye. Emergency Management Safety Director Ethan Cook updated the board on grants and informed the Board that routine storm siren testing will be implemented soon. Sheriff Oscar Juanes discussed an upcoming training event. Motion by Krasser to bring from table and award all low bids for Six Month bids except awarding all limestone products to Dolese Bros. due to travel distance, and award Twelve Month Ballot Printing bids to Mid-West Printing on the advice of Election Board Secretary. Dickey, Krasser, and Hoover voted aye. Motion by Krasser to approve Agreement with Oklahoma Office of the Attorney General for 2025 Sheriff's Office Funding Assistance Grant (SAG). Dickey, Krasser, and Hoover voted aye. Motion by Hoover to approve Resolution #1845 to reappoint Jeff Patterson to serve as Trustee of the Tillman County Emergency Medical Services. Dickey, Krasser, and Hoover voted aye. Motion by Krasser to approve Resolution #1846 to renew Interlocal Agreement between Tillman County and Circuit Engineering District #7 for services in accordance with 69 O.S. § 687.1, FY2025. Dickey, Krasser, and Hoover voted aye. Motion by Krasser to allow Danny Seeley use of Courthouse grounds to operate a free Santa photo booth on Saturday, December 20. Dickey, Krasser, and Hoover voted aye. Motion by Krasser to approve Transfer of Appropriations in the amount of \$50,000.00 from FEMA-4222 to M&O, Highway Fund, Dist. 3. Dickey, Krasser and Hoover voted aye. Motion by Hoover to approve Transfer of Appropriations in the amount of \$1,500.00 from Travel to Salaries, Highway Fund, Dist. 1. 




