Krasser, Dickey and Hoover voted aye. Motion by Krasser to elect Joe Don Dickey to serve as Tillman County Board of Commissioners Chairman, effective January 1, 2025. Krasser Hoover voted aye; Dickey abstained. Motion by Dickey to elect Levi Krasser to serve as Tillman County Board of Commissioners Vice-Chairman, effective January 1, 2025.
