Minutes of the previous meeting were read by County Clerk Cacy Caldwell. Motion by Smith to approve the minutes as read. Dickey, Petty and Smith voted aye. Emergency Management/Safety Director Kyle Davis informed the board that he has accepted a new position, his last day with the County will be February 28. Sheriff Ingram informed the board that the Durango is now in the Department's possession and that he has talked to Chief Neely about sharing repeater space. Chairman Dickey made a statement that at this time the Board will allow the Burn Ban to expire and advises that everyone should use extreme caution and contact their local fire department prior to starting any controlled burns. Motion by Smith to approve Resolution #1591 to hold Fair Board elections on March 7, 2022. Dickey, Petty and Smith voted aye. Motion by Smith to approve Error Correction Transfer in the amount of \$45.63 from Travel to Salaries, Health Fund. Dickey, Petty and Smith voted aye. 




