Small Business Association representative Javier Caltenco addressed the Board regrading SBA disaster assistance loans for homeowners, renters, businesses and non-profit organizations. Motion by Krasser to approve Opioid Abatement Project proposal, as follows: "The Tillman County Opioid initiative led by partner Oklahoma Alliance of Recovery Resources aims to reduce overdose deaths by improving access to treatment and support services through recovery navigation services and recovery friendly workforce initiative. It also expands emergency response with Narcan distribution, enhances community awareness, and strengthens stakeholder collaboration." Dickey, Krasser and Hoover voted aye.
