Motion by Hoover to appoint James Heap as Requisitioning Officer, replacing Kyle Davis, E-911 Board. Dickey and Hoover voted aye. Motion by Hoover to approve Resolution #1729 to participate in the formation of a public trust for the public use and benefit of certain counties located in southwest Oklahoma that have or will receive settlement funds/and/or grants to establish, own and operate a treatment facility (whether one or more) to abate and treat opioid addiction, to include authorization to apply for grant funding from the Oklahoma Opioid Abatement Board and a letter of intent or Memorandum of Understanding to participate in said public trust. Dickey and Hoover voted aye. Motion by Hoover to approve overages on Blanket PO#2009 in the amount of \$200.00 and Blanket PO #2006 in the amount of \$1,232.29, Highway Fund, Dist. 3. 


