Emergency Management/Safety Director Ethan Cook discussed the weather outlook for the week and informed the Board that Grandfield has a siren grant, but needs assistance with the project. Sheriff Oscar Juanes informed the board of a vehicle accident last week. Motion by Krasser to Transfer of Appropriations in the amount of \$5,000.00 from Capital Outlay to M&O, Fair-St Fund. Dickey, Krasser, and Hoover voted aye. Motion by Krasser to Error Correction Transfer in the amount of \$11.48 from Election Board Salaries to General FICA, General Fund. Dickey, Krasser, and Hoover voted aye. 




