Krasser, Dickey and Hoover voted aye. Emergency Management/Safety Director was not at the meeting but reported that he would be attending a virtual meeting with FEMA and OEM regarding DR4776. Sheriff Oscar Juanes informed the Board that Deputy Porter struck a deer on Friday night. He also reported on an active BOLO out of Jackson County. 


