Minutes of the previous meeting were read by County Clerk Cacy Caldwell. Motion by Dickey to approve the minutes as read. Smith, Petty and Dickey voted aye. Sheriff Bill Ingram reported that two of the three new deputies are now active and on the streets. Motion by Dickey to bring from table and award Six-Month Bids, awarding all low bids for crushed materials, hot mix and cold lay, and rejecting all bids for asphalt and asphalt emulsions due to the volatility of the market; purchases for those products will be made through phone quotes. Smith, Petty and Dickey voted aye. Motion by Petty to bring from table and award Twelve Month Bids for ballot printing to low bidder Mid-West Printing. Smith, Petty and Dickey voted aye. Motion by Dickey to declare surplus and offer for sale by sealed bids one (1) pony truss bridge located on CR NS245, Deep Red Creek, Dist. 3. Smith, Petty and Dickey voted aye. Under New Business: Motion by Petty to lease-purchase one (1) Kubota M6-131 DTC-F Tractor and purchase one (1) Land Pride RC5715 Rotary Cutter on state contract, Dist. 1. Smith, Petty and Dickey voted aye. Motion by Dickey to allow Lily-Marie Fraley and Rachel Stout to erect Community Christmas Tree on Courthouse lawn. Smith, Petty and Dickey voted aye. 
