JOINT RESOLUTION NO. 1418

A RESOLUTION RELATING TO THE ADVANCING OF FUNDS BY THE TRUSTEES OF THE TILLMAN COUNTY INDUSTRIAL AUTHORITY IN PRINCIPAL AMOUNT OF NOT TO EXCEED \$25,000.00 TO PROVIDE FUNDS TO PAY CERTAIN EXPENSES FOR THE TILLMAN COUNTY LAW ENFORCEMENT CENTER TRUST AUTHORITY FOR TILLMAN COUNTY, OKLAHOMA; TO BE UTILIZED PENDING RECEIPT OF ACCOUNT RECEIVABLE FROM THE FEDERAL MARSHAL'S OFFICE FOR HOUSING FEDERAL PRISONERS.

WHEREAS, the Tillman County Industrial Authority, a public trust (the "Authority"), has been created by a Declaration of Trust for the use and benefit of Tillman County, Oklahoma (the "County"), under authority of and pursuant to the provisions of Title 60, Oklahoma Statues 1998 Supplement, Sections 176-180.3, inclusive, as amended and supplemented, the Oklahoma Trust Act and other applicable statutes of the State of Oklahoma; and

WHEREAS, the Trustees of the Authority have determined upon a financing plan consisting of providing a portion of the funds required to provide for the payment of certain expenses of the Tillman County Law Enforcement Center Trust Authority facility in Tillman County, Oklahoma pending receipt of accounts receivable from the Federal Marshal's Office for housing federal prisoners; and

WHEREAS, in order to effect the said payment, the Trustees of the Authority intend to advance to the Commissioners of Tillman County, Oklahoma, the aggregate principal amount of not to exceed \$25,000.00, said indebtedness to be evidence by a Repayment Agreement from said Tillman County; and

WHEREAS, the Trustees of the Authority have tendered to the Board of County Commissioners of Tillman County, Oklahoma, a Repayment Agreement and the Board has determined to accept said Repayment Agreement;

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TILLMAN COUNTY, OKLAHOMA:

<u>SECTION 1.</u> The aforesaid plan and the advancing of funds, as submitted, will provide funds for payment of certain expenses of the Tillman County Law Enforcement Center in Tillman County, Oklahoma. The aforesaid assistance will serve the public purposes of the County and hereby is expressly determined to be in furtherance of the public purposes for which the Authority was created.

<u>SECTION 2.</u> The advancing of funds by the Trustees of the Tillman County Industrial Authority in the aggregate principal amount of not to exceed \$25,000.00, in order to provide a portion of the funds required to pay certain expenses for the Tillman County Law Enforcement Center in Tillman County, Oklahoma, is hereby consented and approved by the Board of County Commissioners of Tillman County, Oklahoma, the governing body of said County.

<u>SECTION 3.</u> The form and substance of the Repayment Agreement from the Board of County Commissioners of the County to the Authority hereby is hereby approved. The said Repayment Agreement is hereby accepted and the Chairman and County Clerk hereby are authorized and directed to execute, attest and affix the seal of the County upon said Repayment Agreement in several multiple originals and deliver the same to the Authority.

<u>SECTION 4.</u> By reason of the need of paying certain expenses for the Tillman County Law Enforcement Center in Tillman County, Oklahoma, pending receipt of accounts receivable from the Federal Marshall's Office and for immediate preservation of the public peace, health and safety, an emergence hereby is declared to exist and this Resolution shall be effective immediately upon its adoption.
