RESOLUTION # 1489

BE IT REMEMBERED that on the 26th day of May, 2020, at a regular meeting of the Board of County Commissioners of Tillman County, the following Resolution was presented, read, and adopted:

WHEREAS, Due to the declaration of a State of Emergency regarding the COVID-19 pandemic 81 O.S. § 6101 et seq. by J. Kevin Stitt, Governor of the State of Oklahoma, the referenced duties to be performed in 68 O.S. § 3148 has been amended to include the language:


IN THE EVENT THE GOVERNOR DECLARES A CATASTROPHIC HEALTH EMERGENCY AS PROVIDED AS PROVIDED IN 81 O.S. § 6101 et seq.; THE BOARD OF COUNTY COMMISSIONERS, UPON REQUEST OF THE COUNTY TREASURER, SHALL POSTPONE DELINQUENT TAX SALES AND RELATED DELINQUENT TAX NOTICES AND PUBLICATIONS. THE COUNTY TREASURER SHALL DESIGNATE THE PERIOD OF POSTPONEMENT UP TO BUT NOT MORE THAN ONE YEAR. UPON POSTPONEMENT ACTION BY THE BOARD OF COUNTY COMMISSIONERS, THE COUNTY TREASURER SHALL ADVERTISE THE DETAILS OF THE POSTPONEMENT IN THE SAME MANNER AS OTHER DELINQUENT TAX LEGAL PUBLICATIONS ONCE PER WEEK FOR FOUR CONSECUTIVE WEEKS; and,

WHEREAS, Julie Garza, Tillman County Treasurer, has submitted the following request to the Tillman County Board of County Commissioners:

Please be advised, as Treasurer of Tillman County, I Julie Garza, am requesting the postponement of the 2020 June Resale as specified in the emergency amendment to the legislation due to the adverse effects of the COVID-19 health catastrophe. The 2020 sale will be rescheduled to be held no later than the next scheduled resale on June 14, 2021. When the exact date of the rescheduled sale is determined, it will be advertised in the Frederick Press-Leader for four consecutive weeks prior to the sale date.

NOW THEREFORE BE IT RESOLVED that the Board of County Commissioners, that tax resale referenced in 68 O.S. § 3125 will not be held the 2nd Monday in June of 2020, in accordance with the amendment to 68 O.S. § 3148 and the request of Julie Garza, Tillman County Treasurer.




