RESOLUTION # 1492

BE IT REMEMBERED that on the 8th day of June, 2020, at a regular meeting of the Board of County Commissioners of Tillman County, the following Resolution was presented, read, and adopted:

WHEREAS, Kent Smith, Tillman County District 3 Commissioner, is in charge of the securing of all necessary realty required in the construction and maintenance of the County Transportation System for District 3; and,

WHEREAS, Tillman County District 3 intends to construct a bridge on CR NS 245 between CR EW 187 and CR EW 188, on the Tillman County and Cotton County border. Said bridge-site is referred to as Project # STP-271C(069) CI, State J/P #30700(04); and,

WHEREAS, in order to economically construct and maintain the County Transportation in District 3 and proceed with said Project, it is necessary to acquire interest in the following tract:

Tract: 1, 1.1.1:

A strip, piece or parcel of land in the Southeast Quarter of Section 13 of Township 3 South, Range 14 West, I.M., Tillman County, Oklahoma, more particularly described as follows:

BEGINNING at the Northeast corner of said Southeast Quarter Section; thence S 00° 27' 04" W along the East Boundary Line of said Southeast Quarter Section a distance of 1,030.90 feet; thence N 89° 32' 56" W a distance of 33.00 feet to a point on the West Statutory Right-of-Way Line of the County Road; thence N 00° 27' 04" E along said West Statutory Right-of-Way Line a distance of 300.00 feet; thence N 09° 45' 10" W a distance of 152.41 feet; thence N 00° 27' 04" E a distance of 350.00 feet; thence N 15° 33' 38" E a distance of 103.58 feet to a point on said West Statutory Right-of-Way Line of the County Road; thence N 00° 27' 04" E along said West Statutory Right-of-Way Line of said Southeast Quarter Section; thence S 89° 32' 56" E (Assumed) along the North Boundary Line of said Southeast Quarter Section a distance of 33.00 feet to the POINT OF BEGINNING, containing 1.08 acres, more or less, including 0.78 acres of Statutory Right-of-Way.

Said tract being owned by Trey Adolph Fred Wirz, III, et al; and,

WHEREAS, Tillman County has been unable to affect a reasonable and amicable settlement with the said property owners.

NOW, THEREFORE, BE IT RESOLVED, that there is a public necessity, in carrying out said Project, to acquire by condemnation the real property interest above-described.
