

Passed and approved in regular session this 28th day of January, 2022.



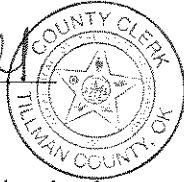
