RESOLUTION # 1633

BE IT REMEMBERED that on the 3rd day of October, 2022, at a regular meeting of the Board of County Commissioners of Tillman County, the following resolution was presented, read and adopted:

WHEREAS, multiple fire departments are charged with the preservation of the health and safety of the citizens of Tillman County, and protection of property within Tillman County. These fire departments are: Chattanooga Fire Department, Davidson Fire Department, Frederick Fire Department, Grandfield Fire Department, Hollister Fire Department, Manitou Fire Department and Tipton Fire Department, collectively "The Fire Departments"; and,

WHEREAS, in the interest of simplifying dispatching protocols and in order to better serve the public, The Fire Departments have agreed upon service district boundaries as listed below and shown on the attached map.
