**RESOLUTION # 1749**

**BE IT REMEMBERED** that on the 19<sup>th</sup> day of August, 2024 at a regular meeting of the Board of County Commissioners of Tillman County, the following resolution was presented, read and adopted:

**WHEREAS**, on the 19<sup>th</sup> of June, 2017, the Board of Tillman County Commissioners adopted and approved Resolution #1347 levying an Excise Tax of two percent (2%) of the purchase price upon the storage, use or consumption of tangible, personal property purchased outside the state of Oklahoma and brought into Tillman County; and,

**WHEREAS**, in preparing the 2024-2025 fiscal year general fund budget, the Tillman County Board of County Commissioners and the Tillman County Excise Board have reviewed the Estimates of Needs submitted and have determined that it is in the best interest of Tillman County to the use said excise tax proceeds within the General Fund for the following purposes for the 2023-2024 fiscal year: Officer Travel, General Fund Salaries, Sheriff M&O, Budget Maker, and Charity.

**NOW, THEREFORE, BE IT RESOLVED** that the Tillman County Board of County Commissioners and the Tillman County Excise Board hereby direct the 1% excise tax, also known as the County Government use tax, to be appropriated to the General Fund and to be used as follows:
