

**RESOLUTION # 1766**

A RESOLUTION PROVIDING FOR FUNDS TO SUPPORT THE PLANNING, FINANCING, CONSTRUCTION AND GENERAL OPERATIONS OF MEDICAL FACILITIES OWNED AND OPERATED BY THE TILLMAN COUNTY-CITY OF FREDERICK HOSPITAL AUTHORITY; THE LEVY OF ONE PERCENT (1%) TAX FOR THE DURATION OF THE PLANNING, CONSTRUCTION AND OPERATION OF SAID MEDICAL FACILITIES, ON THE GROSS RECEIPTS OR PROCEEDS ON CERTAIN SALES AS HEREIN DEFINED; DEFINING TERMS; PRESCRIBING PROCEDURES, REMEDIES, LIENS AND FIXING PENALTIES; FIXING AN EFFECTIVE DATE; MAKING PROVISIONS SEPARABLE; AND DECLARING AN EMERGENCY.

**BE IT RESOLVED** by the Board of Commissioners of Tillman County, Oklahoma:

**SECTION 1 CITATION:**

This Resolution constitutes, shall be known and may be cited as the “Tillman County, Oklahoma, Sales Tax Resolution”.

**SECTION 2 CITATION:**

The definition of words, terms and phrases contained in the Oklahoma Sales Tax Code are hereby adopted by reference and made a part of this Resolution. (68 O.S. § 1352)

**SECTION 3 TAX COLLECTOR DEFINED:**

The term “Tax Collector” as used herein means the Department of the County Government of the official agency of the State duly designated according to law or contract authorized by Law, to administer the collection of the tax herein levied.

**SECTION 4 CLASSIFICATION OF TAXPAYER:**

For the purpose of this Resolution, the classification of taxpayers hereunder shall be as prescribed by State Statutes for purposes of the Oklahoma Sales Tax Code.

**SECTION 5 SUBSISTING STATE PERMITS:**

All valid and subsisting permits to do business issued by the Oklahoma Tax Commission pursuant to the Oklahoma Sales Tax Code are, for the purpose of this Resolution, hereby ratified, confirmed and adopted in lieu of any requirement for an additional governmental permit for the same purpose.

**SECTION 6 EFFECTIVE DATE:**

This Resolution shall become and be effective April 1, 2025, subject to approval of a majority of the registered voters of Tillman County, Oklahoma, voting on the same on January 14, 2025, in the manner prescribed by Oklahoma Statutes. The Sales Tax established by this Resolution shall be assessed and collected for the duration of the operation of the medical facilities owned and operated by the Tillman County-City of Frederick Hospital Authority.

**SECTION 7 PURPOSE OF REVENUE:**

It is hereby declared to be the purpose of this Sales Tax Resolution to provide revenue to support the planning, financing, construction and general operations of medical facilities owned and operated by the Tillman County-City of Frederick Hospital Authority.

**SECTION 8 TAX RATE: SALES SUBJECT TO TAX:**

There is hereby levied an excise tax of one percent (1%) upon the gross proceeds or gross receipts derived from all sales taxable under the Sales Tax Law of Oklahoma, including, but not exclusive of, the following:

- a) Tangible personal property;
- b) Natural or artificial gas, electricity, ice, steam or any other utility or public service except water; and,
- c) Transportation for hire of persons by common carriers, including railroads (both steam and electric), motor transportation companies, taxicab companies, Pullman car companies, airlines and all other means of transportation for hire.

**ELECTION PROCLAMATION**

Pursuant to the provision of 68 O.S. § 1370-1372, inclusive, and pursuant to Resolution # 1766 of the Board of County Commissioners of Tillman County, Oklahoma, authorizing the calling of an election for the purpose hereinafter set forth. I, the undersigned Levi Krasser, Chairman of the Board of County Commissioners of Tillman County, Oklahoma, hereby call a special election to be held on the 14<sup>th</sup> day of January, 2025, within said county of Oklahoma for the purpose of submitting to the qualified electors of Tillman County, Oklahoma, for their approval or rejection of the following proposition:

SHALL RESOLUTION NO. 1766 OF TILLMAN COUNTY, OKLAHOMA, ENTITLED:

A Resolution providing for funds to support the planning, financing, construction and general operations of medical facilities owned and operated by the Tilman County-City of Frederick Hospital Authority, the levy of one percent (1%) tax for the duration of the operation of said medical facilities on the gross receipts or proceeds on certain sales as herein defined; defining terms, prescribing procedures, remedies, liens and fixing penalties; fixing an effective date; making provisions separable; and declaring an emergency. Purpose of revenues: To support the planning, financing, construction and general operations of medical facilities owned and operated by the Tilman County-City of Frederick Hospital Authority.

BE APPROVED?

The ballot used at said election shall set out the proposition as above set forth, and shall also contain the words:

- FIRST FOR THE ABOVE PROPOSITION
- SECOND AGAINST THE ABOVE PROPOSITION

If the voter desires to vote for the above proposition, he shall stamp an "X" in the first square above; if he desires to vote against the above proposition, he shall stamp an "X" in the second square above. There shall be eight (8) precincts open for voting in this election.

Returns of said election will be canvassed by the Election Board of Tillman County and results thereof will be certified by said Election Board to the Board of County Commissioners through the County Clerk.
