

**TILLMAN COUNTY
BOARD OF COUNTY COMMISSIONERS**

RESOLUTION # 18167

BE IT REMEMBERED that on the 27th day of April, 2026, at a regular meeting of the Board of County Commissioners of Tillman County, the following Resolution was presented, read, and adopted:

WHEREAS, O.S. 19, § 601 states in part "The boards of county commissioners of the various counties shall have exclusive jurisdiction over the designation, construction and maintenance and repair of all of the county highways and bridges therein"; and,

WHEREAS, O.S. 47, § 14-113 states "The Director of the Department of Transportation with respect to highways on the state highway system, or local authorities with respect to highways under their jurisdiction, as defined in Title 69 of the Oklahoma Statutes, may prohibit the operation of vehicles on any such highways, or impose restrictions as to the weights of vehicles to be operated upon any state or federal highway or any detour established for such highways, or for any bridge located upon such highways or detours, whenever any such highway, detour or bridge by reason of deterioration, rain, snow or other climatic conditions will be seriously damaged or destroyed unless the use of vehicles thereon is prohibited or the permissible weight reduced. Such restrictions shall be effective when signs giving notice thereof are erected upon the highway, detour, bridge, or portion thereof affected by such action, and the Department of Public Safety has been notified. The purpose of this provision with respect to local authorities is to give such authorities an opportunity to prevent or minimize an immediate threat of serious harm or destruction to any highway, detour or bridge under their jurisdiction due to rain, snow or other climatic conditions. Nothing stated herein shall be construed to grant local authorities the right to issue permits designed to regulate the use of overweight vehicles upon highways subject to their jurisdiction, and the issuance of such permits is expressly prohibited."; and,

WHEREAS, the roads listed below in Tillman County District #3 are in such condition that it is necessary to prohibit interstate thru truck traffic on certain roads to reduce and prevent additional deterioration.


NOW THEREFORE BE IT RESOLVED, that it being in the best interest of the County to preserve deteriorating roads it is necessary to prohibit interstate thru truck traffic and that the Board of Tillman County Commissioners shall erect signs indicating "No Thru-Truck Traffic" on the following roads:

[1] CR NS 223 (commonly referred to as Vo-Tech Road) from State Highway 5 to CR EW 180 (commonly referred to as Highway)

[2] CR EW 180 (commonly referred to as Highway from CR NS 223 (commonly referred to as Vo-Tech Road) to U.S. Highway 183
