**RESOLUTION # 1874**

**A RESOLUTION DESIGNATING H.G. JENKINS CONSTRUCTION LLC AND ITS SUBCONTRACTORS AS AGENT FOR TILLMAN COUNTY FOR THE PURPOSE OF PURCHASING MATERIALS AND PERSONAL PROPERTY TO BE USED IN THE GRANDFIELD PUBLIC SCHOOLS PARKING LOTS PROJECT IN DISTRICT #3, TILLMAN COUNTY AND PROVIDING FOR THE TAX EXEMPTION AS ALLOWED BY 68 O.S § 1356.**

**BE IT REMEMBERED** that on the 18<sup>th</sup> day of May, 2026 at a regular meeting of the Board of County Commissioners of Tillman County, the following resolution was presented, read and adopted:

**WHEREAS**, the Tillman County Board of County Commissioners has entered into a contract with H.G. Jenkins Construction LLC (Contractor) for the purpose of the Grandfield Public Schools Parking Lots Project in District #3, Tillman County; and,

**WHEREAS**, it will be necessary for the Contractor to purchase materials and tangible personal property in constructing and completing the project. It is intended that in making such purchases, the Contractor will be acting as the agent of the County and not as a private contractor; and,

**WHEREAS**, materials and tangible personal property purchased by the Contractor and its sub-contractors, to be use din this project, will be delivered to the job site and incorporated into the project. The title to such property is to pass form the vendor directly to the County. The purchases of such materials and tangible property are entitled to the exemption from sales tax as provided in 68 O.S. § 1356.

**NOW THEREFORE BE IT RESOLVED** by the Tillman County Board of County Commissioners as follows:

- Section 1:** H.G. Jenkins Construction LLC is hereby designated as the agent for Tillan County for the purpose of purchasing materials and tangible personal property to be used and incorporated in the Grandfield Public Schools Parking Lots Project in District #3, Tillman County, pursuant to the contract dated May 11, 2026 between Tillman County and H. G. Jenkins Construction LLC.
- Section 2:** Materials and personal property purchased pursuant to the said contract and under the authority of this resolution shall be delivered to the job site and title to such property shall pass from the vendor directly to Tillman County.
- Section 3:** All materials and tangible personal property purchased for the said project pursuant to this resolution shall be entitled to the tax exemptions allowed by 68 O.S. § 1356.
- Section 4:** The provisions of this resolution shall apply to any subcontractors of H. G. Jenkins Construction LLC who purchase materials and tangible personal


property for the said project. The subcontractors designated by H.G. Jenkins Construction LLC for the purpose of carrying out this project are designated in Exhibit A, attached hereto.


Section 5: The provisions of this resolution shall expire and terminate upon the completion of the project in questions, but not later than June 30, 2026.
