The Board of Tillman County Commissioners is accepting sealed bids for Fair Barn including HVAC unit and duct work, metal wall sheeting, spray foam insulation, overhead door, walk-through doors, and removal of false ceiling and lighting. Bids shall be in writing and contain an Affidavit of Non-Collusion. The envelope should be plainly marked "**Bid #5-2023, FAIR BARN PROJECT**" on the lower left corner and mailed to the Tillman County Clerk, P.O. Box 992, Frederick, OK 73542 or delivered to the Tillman County Clerk, 201 N. Main, Frederick, OK. Bids will be accepted until bid opening time at **10:00 A.M., Monday, May 15, 2023**. The Commissioners will determine the lowest and best bid, and reserve the right to reject any or all bids.

TERMS AND CONDITIONS

1. Sealed bids will be opened in the Commissioner's Conference Room, Tillman County Courthouse, Frederick, Oklahoma, at the time and date shown on the invitation to bid form.
2. Late bids will not be considered. Bids must be received in sealed envelopes (one to an envelope) with bid number written on the outside of the envelope.
3. Unit prices will be guaranteed correct by the bidder.
4. Firm prices will be F.O.B. destination.
5. Purchases by Tillman County, Oklahoma, are not subject to state or federal taxes.
6. This bid is submitted as a legal offer and any bid when accepted by the County constitutes a firm contract.
7. Oklahoma laws require each bidder submitting a bid to a county for goods or services to furnish a completed and notarized Affidavit of Non-Collusion which is provided below.

AFFIDAVIT OF NON-COLLUSION

I, the undersigned, of lawful age, being first duly sworn on oath say the he (she) is the agent authorized by the bidder to submit the above bid. Affiant further states that the bidder has not been a party to any collusion among bidders in restraint of freedom of competition by agreement to bid at a fixed price or to refrain from bidding; or with any state official or employee as to quantity; quality or price in the prospective contract or any other terms of said prospective contract; or in any discussions between bidders and any state official concerning exchange of money or other thing of value for special consideration in the letting of a contract; that the bidder/contractor has not paid, given or donated or agreed to pay, give or donate to any officer or employee of the State of Oklahoma (or other entity) any money or other thing of value, either directly or indirectly in the procuring of the award of a contract pursuant to this bid.

Tillman County Commissioners will be accepting sealed bids for Fair Barn improvement projects including HVAC Units and duct work, metal wall sheeting, spray foam insulation, overhead door, walk-through doors, and removal of false ceiling and replacement of lighting.

Bids shall include all labor and materials.

Bidders may bid on any single project or all three projects set out in the specifications.

Specifications may be picked up in the Tillman County Clerk's office or by calling (580) 335-3421. Bids shall be in writing and contain an Affidavit of Non-Collusion. The envelope should be plainly marked "**Bid #5-2023, FAIR BARN PROJECT**" on the lower left corner. Bids will be received until bid opening at **10:00 A.M., May 15, 2023**. Late submissions will not be considered.

The County reserves the right to reject or accept any or all bids or to enter into negotiations with any bidder, or to modify the contract documents and re-bid the project, if necessary, to meet Owner's budgetary requirements. The owner reserves the right to waive any alleged breach of technicality.

Project #1 – Install HVAC Unit

- Install two (2) 5-ton split units with gas heat running electric from Main Panel with exposed spiral ductwork. Inner units to be located inside closet.

Project #2 – Enclosing Front Barn

- Complete False Ceiling Throughout Barn and Install 1” closed-cell plus 3” open-cell Spray Foam Insulation
- Install 1” closed-cell plus 3” open-cell Spray Foam Insulation and cover with Flat Black Paint as follows:
 - o From Cinder Block to Ceiling on East Wall
 - o Roof Line of North and South Walls
- Install 1” closed-cell plus 3” open-cell Spray Foam Insulation along West Wall (West Side of Wall) and Install 10’ metal sheeting on West Wall (West Side of Wall)
- Install Overhead Door on West Wall (Using Existing Opening in Middle of Wall)
- Install Walk-Through Door with Windows on West Wall North of Overhead Door
- Install 10’ x 12’ Corner Finished Walls with Insulation with Double Walk-Through Doors with Windows and Flat Roof in Southwest Corner
