4. This bid is submitted as a legal offer and any bid when accepted by the County constitutes a firm contract.
5. Oklahoma laws require each bidder submitting a bid to a county for goods or services to furnish a completed and notarized Affidavit of Non-Collusion which is provided below.

AFFIDAVIT OF NON-COLLUSION
